

- iv) It may be noted that in the event of refusing the above promotion the officials getting promotion as per this order shall be debarred from promotion to the post of Office Superintendent for a period of one year from the date of refusal of the said promotion or till a next vacancy arises, whichever is later, as per the D.O.P & T's O.M. Consequent to cancellation of promotion to the post of Office Superintendent, no fresh offer of appointment on promotion to the post of Office Superintendent shall be made in the cases of above mentioned officials for a period of one year from the date of refusal of promotion or till next vacancy arises, whichever is later.
