- ii) All the officials who were otherwise on sanctioned leave or training or have been requisitioned by the State Election Commission are deemed to have joined the office of the Pr. CCIT, West Bengal & Sikkim after the completion of their sanctioned leave or training or requisition period, if their leave or training or requisition period expires on or before 27.11.2014.
- iii) All the officials who are in continuous service are deemed to be released from the office of the Pr. CCIT, West Bengal & Sikkim on 27.11.2014 (afternoon), provided they have not joined any other charge. These officials have to join their new places of posting on **28.11.2014(forenoon)**.
- iv) All the officials who were otherwise on sanctioned leave or training or have been requisitioned by the State Election Commission and their leave period or training or requisition period expires on or after 27.11.2014, are required to join their new place of posting on 28.11.2014 (forenoon) or after expiry of their sanctioned leave or training or requisition, whichever is later.


