Deployment of Senior Tax Assistants :

Services of the following Senior Tax Assistants named in this Order are withdrawn from their present places of postings (in any Ward / Circle / Range / Section or any other office under the charges of the CCsIT / DGsIT / CsIT / DsIT / Addl.Cs IT / Addl.DsIT / JCsIT / JDsIT mentioned in Column - 4) and placed at the disposal of CCsIT / DGsIT / CsIT / DsIT / Addl.Cs IT / Addl.DsIT / JCsIT / JDsIT as mentioned against their names in Column - 5 with immediate effect until further Orders.

2. This Order is passed in **supersession of all earlier Orders** passed in respect of the officials named in the Order.

3. All the officials mentioned in the Order should be relieved on or before **31.07.2012** positively under intimation to this office. No representation whatsoever will be entertained before the officials join at their new places of posting . All the Heads of offices should sent compliance reports regarding relieving and joining of the officials to this office by **07.08.2012**.

4. The persons who are posted in **Mofussil offices** should join their new place of posting on or before **06.08.2012** without any fail. Otherwise the services rendered by them in Mofussil offices during 2012-13 will not be counted for the purpose of determining the tenure of their stay in Mofussil offices at the time of their return from such Mofussil offices in the subsequent this office's Annual General Transfer Order.

5. No representation whatsoever will be entertained before the officials join at their new places of posting.

6. All Administrative CsIT are requested to rotate the officials posted under his/her charge, whenever the officials completed 2 years under one particular CIT/ Range Office.

7. **With this Order, all representations for postings and transfers in the grade of Senior Tax Assistant stand disposed off.**


