**Deployment of Tax Assistants :-**

2. This Order is passed in **supersession of all earlier Orders** passed in respect of the officials named in this Order.

3. All the officials mentioned in this Order should be relieved on or before **10.10.2014** positively under intimation to this office. **No representation whatsoever will be entertained before the officials join at their new place of posting.** All the Head of offices should sent compliance reports regarding relieving and joining of the officials to this office by **17.10.2014**.

4. The persons who are posted in **Mofussil offices** should join their new place of posting on or before **20.10.2014** without fail otherwise the services rendered by them in Mofussil offices during 2014-15 will not be counted for the purpose of determining the tenure of their stay in Mofussil offices at the time of their return from such Mofussil offices in the subsequent this office's Annual General Transfer Order.

5. **All Administrative CsIT are requested to rotate the officials posted under his/her charge, whenever the official completes 2 years under one particular CIT/ Range Office.**
