i) a) The promotees concerned appearing at Sl.111 to 139 & 151 to 152 in the table above are allowed promotion against R.Y. 2012-13 since they are found eligible for such promotion after counting their past services in the feeder grade rendered by them in old charges prior to their joining to this charge on inter charge transfer, as an interim measure and in pursuance of Honourable Principal Bench CAT New Delhi judgment dated 24.08.06 in O.A No. 2406/2005, Promod Kumar Vs.U.O.I & Others and judgement dated 29.09.10 in OA No. 2732/2009, Sri Nandram Singh Vs.U.O.I . However, the matter has already been referred to the CBDT, New Delhi for specific clarification in this regard. If any specific contrary instruction is received from CBDT in future, these promotees will be liable to immediate reversion and they will not be entitled to claim benefit of this promotion in that event.

b) The persons appearing at Sl no. 79 to 110 & 149 to 150 of the above Table are allowed promotion against R.Y. 2012-13 since they are senior in the feeder grade to the persons mentioned in the preceding paragraph, after applying the provision to the recruitment rules, which, inter alia, prescribe that if a junior person is considered for promotion then a senior persons will also be considered for such promotion, not withstanding that such senior persons do not complete the prescribed residency period of three years in the feeder grade but have completed the period of probation (2 years) in the feeder grade. In case of reversion of the persons mentioned in preceding paragraph, the promotions of these persons will also be reviewed accordingly.

ii) Persons appearing at Sl. 140 to 152, who have passed the departmental examination for ministerial staff in relaxed standard, are promoted as Sr. Tax Assistant against unreserved vacancies temporarily, keeping in abeyance the operation of DOP&T's O.M. No. 36012/45/2005-Estt.(Res.) 10.08.2010 in view of certain judgements of the judiciary .

The promotion of the above mentioned persons are subject to review on finality of the matter either by the DOP&T or by the Supreme Court. They will be liable to reversion, if required, on such review and they will not be entitled to claim any benefit of this promotion on that event.

iii) The promotees concerned are also liable to be reverted without prior notice for any other reason at any time.

iv) The inter-se seniority of the promotee on promotion as Senior Tax Assistant will be fixed immediately below **Shri Subhendu Mondal,(SC)(DOB: 05.02.81)**, the last person promoted as Senior Tax Assistant against Recruitment Year 2011-12 vide Order No.19 dated 09.05.12 of F No. 5E/3/2001-02/Part-I.

v) The above persons are hereby asked to exercise his options within one month of the date of promotion in the matter of fixation of pay on such promotion in terms of Clarification 2 of O.M.F.No 1/1/2008-1C G.I.M.F, Deptt. of Expenditure (Implementation Cell) dated 13th September,2008.

vi) The above persons will please note that in the event of his refusing promotion he will be debarred from promotion to the post of Tax Assistant for a period of one year from the date of refusal of said promotion or till a next vacancy arises, whichever is later, as per the D.O.P. & T's OM No. 22011/5/91-Estt(D)dated 27.03.97.

PART-II : Posting

i) The officials will, on promotion as **Sr.Tax Assistant**, join in their present places of posting until further order.

ii) The promotees concerned are directed to join on promotion at the earliest. They are also directed to intimate in case of declining promotion to the post of **Sr.Tax Assistant**, if any, to this office immediately.

iii) The above postings on promotion are purely temporary and the promotees concerned are liable to be transferred to any office within the West Bengal region at any time.

iv) Heads of offices are requested to ensure that the copy of the joining report is sent to the office of the Addl. C.I.T., Hqrs, (Personnel), Kolkata as soon as the said persons join on promotion.
