On upgradation under the MACP Scheme, the pay of the officials concerned will be raised by an increment of 3% of the total of Pay-in-pay band and Grade Pay before such upgradation, in addition to the higher Grade Pay allowed under the scheme.

The financial upgradation under the MACP Scheme shall be purely personal to the incumbent concerned and shall have no relevance to the seniority position.

In case of the persons appearing in the above table who have got promotion as Office Superintendent / Stenographer Grade I on or after 01.01.2006 but before the date(s) of their financial upgradation(s) to the grade pay of Rs.4600, as mentioned against their names in the above table, the benefit under the scheme is allowed without taking into consideration their promotion(s) to the grade of Office Superintendent/ Stenographer Grade I as mentioned above, since no financial benefit in terms of grant of promotional increment has been allowed in view of objection of Zonal Accounts Office against grant of such increment. The matter is under consideration of the competent authority and if it is decided in future that promotional increment will be available to those incumbent on promotion as Office Superintendent / Stenographer Grade I, the benefit allowed under MACPS will be reviewed accordingly.

In case of the persons appearing in the above table who had got promotion as Tax Assistant (Pre restructuring) in the pre revised pay scale of Rs.4500 – 125 – 7000/- the benefit under the scheme is allowed ignoring such promotion in terms of CBDT's letter F. No.A-41015/58/2010-Ad.VII dated 22.07.10 read with letter F. No.A-41015/66/2000-Ad.VII (Pt) dated 09.07.01.
