CIRCULAR

**Sub: Circulation of Final Seniority List of the cadre of Inspector of Income Tax, for the Recruitment Years: 2003 - 04 to 2012 - 13, in the region of West Bengal and Sikkim -- Matter regarding.**

In view of the Hon'ble Apex Court's judgment in the case of N. R. Parmar vs. Union of India and Ors., (Civil Appeal Nos. 7514 - 7515 of 2005) and in pursuance of the DOP & T's O. M. No. / 20011 / 1 / 2012 - Estt. (D) dated 04.03.2014, as forwarded and directed by the CBDT vide instructions in F. No. HRD / CM / 220 / 14 / 2013 - 14 / 153 / 2014 - Ad. - VII dated 13.03.2014, and CBDT's guidelines dated 29.09.2014, 07.11.2014, & 16.01.2015, the gradation lists of ITIs for the Recruitment Years: 2003 - 04 to 2012 - 13, in the region of West Bengal and Sikkim, is hereby revised and the Final Seniority Lists is published in accordance with the principles as follows:

1. Seniority list has been prepared in accordance with the rotation of vacancies between direct recruits and promotees based on the quota of vacancies reserved for direct recruitment and promotion respectively in the existing recruitment rules (1 : 2 in case of Inspector of Income Tax).
2. The term availability, as used in the DoP & T's circular dated 07.02.1986 & 03.07.1986, has been interpreted in terms of the directions contained in the DoP & T's circular (cited 'supra') dated 04.03.2014. In brief, for Direct Recruits to the grade of ITIs, the Recruitment Year has been interpreted to be the financial year in which the requisitions for filling up of vacancies were sent to the recruiting agencies. The inter - se seniority of the respective Direct Recruits amongst themselves has been fixed as per the relevant merit lists as finalized by the SSC, and communicated by the CBDT. In respect of the promotees, the Recruitment Year has been interpreted as the financial year in which proposals for holding DPC meetings for promotion to the grade of ITIs were placed before the DPC. However, wherever the process of promotion was initiated and DPC was held before the commencement of the relevant vacancy year, the relevant vacancy year is taken as the recruitment year. The cases of inter - charge transferees have been

considered in accordance with the existing rules and instructions. In case of Direct Recruitment also, where requisitions were sent to SSC / CBDT, before the commencement of the relevant vacancy year, such relevant vacancy year was taken as the recruitment year for the purpose of parity and also as in accordance with the CBDT's instructions.

3. In accordance with the above, the data as per following schedule has been utilized:

While finalizing the list, various representations received after publication of tentative list in this regard raising certain objections, are disposed of as follows:

**Objection No. 1:** Vacancy of direct recruitment quota for Inspector of Income Tax, for the Vacancy Years: 2009 – 10 & 2010 – 11, were reported to CBDT. However, as per this office Circular dated 07.10.2015, all such direct recruit Inspectors of Income Tax, were placed in the Recruitment Year: 2010 – 11.

**Reply No. 1:** The Board's advisories dated 29.09.2014, 07.11.2014, & 16.01.2015, clarifies that the candidates selected from the Examination for the year: 2010, are to be placed in the Recruitment Year: 2010 – 11. The said clarification has been adopted while preparing the revised seniority list for the cadre of ITIs in respect of the direct recruits selected by the SSC from the Examination for the year: 2010. It may be mentioned here that, no candidate from the Examination for the year: 2009, was recommended by the CBDT for appointment in the grade of ITI, in this Charge.

**Objection No. 2:** The requisition date of direct recruit Inspector of Income Tax, to the recruiting agency, for the Vacancy Year: 2011 – 12, was 02.02.2011. This date falls within the Financial Year: 2010 – 11. However, as per this office Circular dated 07.10.2015, all such direct recruit Inspectors of Income Tax, were placed in the Recruitment Year: 2011 – 12.

**Reply No. 2:** The Board's advisories dated 29.09.2014, 07.11.2014, & 16.01.2015, clarifies that the candidates selected from the Examination for the year: 2011, are to be placed in the Recruitment Year: 2011 – 12. The said clarification has been adopted while preparing the revised seniority list for the cadre of ITIs. Moreover, the CBDT, in its advisory dated 07.11.2014, has clarified in Point No. 1 that, in case requisition has been made in advance (i. e. before the year in which vacancy arises), the vacancy year shall be adopted as the year of seniority. The procedure adopted by this office for fixing seniority of direct recruits for the Vacancy Year: 2011 – 12, is in consonance of such clarification of CBDT.

**Objection No. 3:** Para 2.4.4 of DoP & T's O. M. 03.07.1986 has not been followed while preparing the revised seniority list.

**Reply No. 3:** The Board's advisories dated 29.09.2014, 07.11.2014, & 16.01.2015, clarifies that Para 2.4.4 of the DoP & T's O. M. dated 03.07.1986, was not the subject matter of the Hon'ble Supreme Court judgement, and hence, it is not required to be dealt with here. The said clarification has been adopted while preparing the revised seniority list for the cadre of ITIs.

**Objection No. 4:** The judgement of the Hon'ble Apex Court in the case of Arvind Kumar Trivedi & Ors. Vs. Rajeev Mohan & Ors. Dated 11.03.2014, in case of inter – region transferees, judgement of Principal Bench, CAT, dated 29.05.2014, in the case of Patanjali Sharma vs. U. O. I., DoP & T's OM dated 09.08.1995, was not followed while drawing up the revised seniority list.

**Reply No. 4:** No direction has been received by this office from the DoP & T / CBDT for implementation of the judgement as aforesaid till date. This office acts as a subordinate office of CBDT, and cannot implement the judgements in the aforesaid cases without any direction from the CBDT.,

**Objection No. 5:** Inter – se seniority of direct recruits should be fixed in the chronological order of receipt of panels from the recruiting agency (SSC / CBDT).

**Reply No. 5:** Inter – se seniority of direct recruitees in revised seniority list for the cadre of ITIs has been fixed in accordance with the rank of the candidates in the merit lists as intimated by the Staff Selection Commission in its various letters for nomination of such candidates. The procedure adopted is fully in consonance with the provision of DoP & T in this regard, vide its O. M. dated 03.07.1986.

All other amendments regarding the spelling of names, category, date (s) of births, date (s) of joining, etc., have been made in accordance to various representations, after tallying with the available office records. The comparative positions of some of the promotees have changed due to revision in the feeder grades for promotion to the grade of Inspector of Income Tax (as prescribed in the existing Recruitment Rules for promotion to the grade of Inspector of Income Tax), in accordance with the judgement of the Hon'ble Supreme Court, in the case of N. R. Parmar & Ors..



All the representations received in this office of the undersigned after publication of the tentative seniority list in the matter pertaining to the Recruitment Years: 2003 – 2004 to 2012 – 2013, stand disposed of with the publication of the final seniority list as appended hereto.

The Final Seniority List of Inspector of Income Tax for the Recruitment Years: 2003 – 2004 to 2012 – 2013, is published with the approval of the Principal CCIT, WB & Sikkim.
