#### Part F:

The CCsIT(ReAC) in this region may change the posting of the officials in the grade of Inspector of Income Tax under their jurisdiction on account of administrative work related exigencies. #### PART G:

- In the case of employees who are on sanctioned leave / in training as on 22.12.2020, this order will take effect on their return from such leave / training.
  - ii) The joining time shall be admissible as per DOP&Ts notification dtd.27.03.2015 in this regard.
- iii) With this order, all representations/options for transfer & posting in the grade of Income Tax Inspector in West Bengal & Sikkim region received by this office till date, stand disposed off. No further request regarding transfer and posting will be entertained unless the official concerned join to his/her new place of posting.
- iv) Officials effected by this transfer order except for officials due for transfer mentioned at Sl.No. 5,13,16 of Part A are not entitled for any Transfer Allowances as the order is made on the basis of their representations.
- v) All the officials in the cadre of Inspector of Income Tax in West Bengal & Sikkim Region who have been transferred by this order should be relieved on or before 29.12.2020 positively under intimation to this office, except those, who are involved in Vivad Se Viswas (VsV) Scheme related works for which necessary order have been made by the concern PCIT/CIT for this purpose. Officials who are not involved in VsV related works shall be treated as "Stand released" w.e.f. 29.12.2020 (AN) from their present/erstwhile places of posting.
- vi) Transfer & posting of all the officials in the cadre of Inspector of Income Tax, West Bengal & Sikkim Region, effected by Part A of Order No17 dated 01.10.2020 issued from the even file but not covered in this order shall also be treated as "stand released" w.e.f. 29.12.2020 (AN) from their present/erstwhile places of posting unless they have already joined their new assignment as per such order by this time. However, this clause will not be applicable to those Inspector of Income Tax who are involved in Vivad Se Viswas(VsV) Scheme related works for which necessary order have been made by the concerned PCIT/CIT for this purpose.
- vii) The concerned A.O./D.D.Os in charge of drawing & disbursing pay & allowances of the officials under order of transfer as per this order & also Order no.17 dated 01.10.2020 as mentioned above, are hereby directed not to draw any pay & allowances in respect of such officials from the month of January, 2021 onwards.

viii) All the Head of Offices should send compliance reports where applicable, for relieving and joining of the officials to this office latest by 05.01.2021.
