Part-A: Promotion :

In pursuance of C.B.D.T.'s instruction vide its letter F.No. HRD/CM/102/2/2014-15/7062 Dated: 02.12.2014, the following officials are promoted to the grade of **Inspector of Income Tax** in the Pay Band of Rs. 9300 - 34800/- with Grade Pay of Rs. 4600/- plus usual allowances against existing vacant posts for the **R.Y. 2014-15** with effect from the date they join for duty and until further orders.

i) The above mentioned officials, being promoted as per this order, are liable to be reverted without prior notice at any time.

ii) The inter-se seniority of the abovementioned persons in the promotional cadre of Inspector will be fixed enbloc immediately below **Shri Madan Kr. Chhatui (DOB : 03.01.1964)**, the last person promoted as Inspector against **Recruitment Year 2013-14 vide Order No. 26 dated 10.06.2014 of F. No. 4E/4/2014-15.**

iii) The above **promotees** are hereby asked to exercise their option within one month of the date of promotion in the matter of fixation of pay on such promotion in terms of Clarification 2 of O.M. F. No. 1/1/2008-1C G.I.M.F, Deptt. of Expenditure (Implementation Cell) dated 13th September, 2008.

iv) It may be noted that in the event of refusing the above promotion the officials getting promotion as per this order shall be debarred from promotion to the post of Inspector for a period of one year from the date of refusal of the said promotion or till a next vacancy arises, whichever is later, as per the D.O.P & T's O.M. No. 22011/5/91-Estt.(D) dated 27.03.97.

v) The persons appearing at **Sl.No. (s) 2,3,6,7,8,10,11 & 12**, in the above table are selected for promotion against available **SC vacancies** . All other persons are selected against **unreserved** vacancies.

vi) Promotions of the above said persons are given on the basis of the existing Recruitment Rules, as directed vide Board,s letter dated 27.05.2014, and as per the existing gradation lists of the feeder grades. This order will remain subject to revision contingent upon the revision, if any, of the said gradation lists of feeder cadres in view of the decision of the Hon'ble Supreme Court in the case of N.R. Parmar & Ors. read with Dop & T' s O. M. dt 04.03.2014 & CBDT's letter dt. 06.06.2014, 29.09.2014 & 07.11.2014 communicating further clarification of the DOPT's O.M. dt. 04.03.2014 in this regard.

vii) The promotees concerned are directed to join on promotion as Inspector at the earliest. They are also directed to intimate their unwillingness, if any, to accept the promotion to the post of Inspector to this office by **16.01.2015** positively.

Part-B: Reversion

Consequent upon promotion of Shri Swapan Kr. Biswas (D.O.B.- 10.12.1970), O.S to the post of Inspector of Income Tax, is hereby reverted back to the parent department i.e. Income Tax Department West Bengal from the Competent Authority and Administrator, SAFEMA(FOP) & NDPSA, Kolkata, Govt. of India, Ministry of Finance, Department of Revenue. On reversion the services of Shri Biswas is placed under the disposal of Addl. CIT, HQRS, (PERSONNEL & ESTT.),KOLKATA, with immediate effect and until further order.
