Part-A: पदोन्नति/Promotion:

The following officials are hereby promoted to the post of Inspector of Income Tax as per revised pay of 7th CPC in the pay matrix level 7 plus usual allowances as applicable. The officials are promoted **purely on ad-hoc basis** with immediate effect. Such ad-hoc promotions will take notional effect from the date(s) mentioned against their names.

i) The above names are released for ad-hoc promotion as Inspector of Income Tax in view of the judgment of the Hon'ble CAT, Calcutta Bench, Kolkata, in O.A. No. 350/00615/2018 dated 13.12.2018 and after the kind approval of the Principal Commissioner of Income Tax, West Bengal and Sikkim.

ii) The promotion is valid for one year in terms of Para No.07 of DoP&T's O.M. No. 28036/1/2001-Estt.(D) dated 23.07.2001. The above promotion on **ad-hoc basis** shall not confer on the officials concerned any right to claim seniority in the grade of Inspector of Income Tax or regular promotion as Inspector of Income Tax.

iii) All the conditions prescribed in the existing DoP&T's instructions shall be applicable to this promotion.

iv) This promotion is subject to any subsequent O.M./clarification/instruction of the DoP&T/CBDT regarding the procedure of implementation of such judgment of the Hon'ble Supreme Court of India dated 26.09.2018, in SLP(C) No. 30621/2011, or any such judgment of the Hon'ble Supreme Court of India. In this regard, the above officials are liable to be reverted at any time without assigning any reason, as a consequence of it.

v) The ad-hoc promotions of the above said officials are based on the revised seniority list published after giving effect to the judgment of the Hon'ble Apex Court's in the N.R. Parmar & Ors. Vs Union of India & Ors., and is subject to change in seniority of any official subsequent to any representation received later on by this office and/or any decision of any proceeding pending before any tribunal/court/CBDT/DoPT.

vi) The above ad-hoc promotions are made as per the seniority of the eligible candidates in the feeder grades without any element of reservation of SC/ST category.

vii) The promotees concerned are directed to join on promotion as Inspector of Income Tax at the earliest. They are also directed to intimate their unwillingness, if any, to accept the promotion to the post of Inspector of Income Tax to this office by **one month from the date of this order** positively, **otherwise action will be taken as per extant rules**.

viii) The above mentioned officials are not entitled to exercise the option in the matter of fixation of pay. Such option can be given only on their regular promotion as Inspector of Income Tax against regular vacancies.

- i) On promotion as Inspector of Income Tax, the services of the officials mentioned in Part – A are retained at their present places of postings until further orders. - ii) The above posting on promotion is purely temporary and the promotees concerned are liable to be transferred to any office within the Principal CCIT West Bengal and Sikkim region.
- iii) Head of offices are requested to ensure that the copy of the joining report is sent to the office of the Addl.CIT,Hqrs.,(Personnel & Establishment), Kolkata as soon as the said persons join on promotion.


