**Part-A: पदोन्नति/Promotion:**

Saha (D.O.B: 10.10.51) in seniority list the cadre of Inspector of Income Tax in the vacancy year 2009-10, as finalized in implantation of the Hon'ble Apex Court's judgment in the N.R. Parmar case.
