Part-A: Promotion :

In pursuance of C.B.D.T.'s instruction vide its letter F.No. HRD/CM/102/10/2014-15 Dated: 17.06.2015, the following officials are promoted to the grade of **Inspector of Income Tax** in the Pay Band of Rs. 9300 - 34800/- with Grade Pay of Rs. 4600/- plus usual allowances against existing vacant posts for the **R.Y. 2015-16** with effect from the date they join for duty and until further orders.

- The inter-se seniority of the above mentioned promotees on promotion as Inspector of Income Tax will be fixed immediately below **Shri Indranil Dutta/UR/HH (D.O.B.: 28.08.78)** the last person promoted as Inspector against **Recruitment Year 2014-15** vide Order No. 278 dated 16.03.2015 from F. No. 4E/1/2014-15.
- The above **promotees** are hereby asked to exercise their option within one month of the date of promotion in the matter of fixation of pay on such promotion in terms of Clarification 2 of O.M. F. No. 1/1/2008-1C G.I.M.F, Deptt. of Expenditure ( Implementation Cell ) dated 13<sup>th</sup> September, 2008.
- It may be noted that in the event of refusing the above promotion the officials getting promotion as per this order shall be debarred from promotion to the post of Inspector for a period of one year from the date of refusal of the said promotion or till a next vacancy arises, whichever is later, as per the D.O.P & T's O.M. No. 22011/5/91-Estt.(D) dated 27.03.97.

V)The persons appearing at **Sl.No. 01, 02, 03 and 06** are selected for promotion against UR vacancies and **Sl. No. 04 & 05** of the above table are selected for promotion against SC vacancies.

Vi) Promotions of the above said persons are given on the basis of the existing Recruitment Rules, as directed vide Board,s letter dated 02.12.14, and as per the existing gradation lists of the feeder grades. This order will remain subject to revision contingent upon the revision of the said gradation lists of feeder cadres in view of the decision of the Hon'ble Supreme Court in the case of N.R. Parmar & Ors. read with Dop & T' s O. M. dt 04.03.2014 & CBDT's letters dt. 06.06.2014, 29.09.2014 & 07.11.2014, communicating further clarification of the DOPT's O.M. dt. 04.03.2014, in this regard.

vii) The promotees concerned are directed to join on promotion as Inspector at the earliest. They are also directed to intimate their unwillingness, if any, to accept the promotion to the post of Inspector to this office by **one month from the date of this order** positively. Otherwise action will be taken as per extent rules.

#### Part-B: Posting

i) On promotion as Inspector of Income Tax, the services of the officials mentioned in Part – A are retained at their present places of postings until further orders expect SL NO-05 who is directed to join at CIT-5 as Inspector on or before 08/07/2015.

ii) The above posting on promotion is purely temporary and the promotees concerned are liable to be transferred to any office within the **Principal CCIT West Bengal and Sikkim** region.

iii) Head of offices are requested to ensure that the copy of the joining report is sent to the office of the Addl.C.I.T.,Hqrs.,(Personnel), Kolkata as soon as the said persons join on promotion.
