Dear Comrades,

Sub: The call for Agitation

As per the decision of the Central JCA, the Notice for one day Strike on 08-10-2015 has been given to the CBDT by the Central JCA on 09-09-2015 along with the letter intimating the Chairperson about the programme of agitation to be commenced on 09-09-2015. Lunch-hour demonstration was held by the state JCA units on 09-09-2015 in all Pr. CCIT and other CCIT/CIT offices throughout the country and the copy of the Strike Notice was also served on the respective Pr. CCsIT.

The non-cooperation movement has been commenced from 09-09-2015 in the following manner:

- i) Stoppage of work relating to widening of tax-base.
- ii) No work relating to I & CI job like uploading of CIB data, disposal of verification cases, etc.
- iii) Artificial deadlines for completion of scrutiny assessments will not be adhered to.

**The Central JCA has now decided to include the non-submission of reports (except the Parliamentary Questions and Audit Queries) from 15-09-2015 as part of the intensification of the ongoing non-cooperation movement and the same is intimated to the Chairperson, CBDT, on 14-09-2015 (the copy of the letter to the Chairperson, CBDT dated 14-09-2015 is attached). The state JCA units are requested to submit the same to the respective Pr.CCsIT on 15-09-2015).**

Decision has also been taken to release a Press-brief, by way of holding Press-conference wherever possible, by the Central JCA and all the Units of JCA on 23-09-2015 (the draft Press-brief is also attached along with). All the Units of JCA are requested to give wide-publicity of the non-cooperation movement among the members and also to organise Press-conference/Press-release on 23-09-2015.

We also reiterate the programme of actions decided by the Central JCA:


1. Black-flag Demonstration before the Chairperson and Members of CBDT on their visit in any office outside the North Block.
2. **Day-long Dharna** in front of all Pr.CCIT and other CCIT/CIT offices on 15-09-2015.
3. **Half-day walk-out** from 2.00 PM on 01-10-2015.
4. **Strike action on 8<sup>th</sup> October, Thursday, 2015.**

It has also been decided to intensify the agitation after 08-10-2015 if no acceptable settlement is brought out by the above date.

Though the CBDT has called upon the Central JCA in a meeting on 16-09-2015 to discuss the 5(five) point Charter of Demands submitted by the JCA, the attitude of the CBDT till date does not show any intention to resolve the issues positively. Only a sustained and intensive agitation can bring a fruitful discussion with the authority and so, all the Units/Circles of ITGOA/ITEF are requested to observe the programme of agitation jointly ensuring the active participation of all its members. **Special emphasis must be given that the reports are not submitted from 15-09-2015.** An extensive campaign programme for the Strike action on 08-10-2015 has also to be carried out.
