Kindly refer to the above.

I have been directed to draw your kind attention to your letter under reference [copy enclosed] vide which it has been asked to examine the option of holding re-examination of Paper II [Office Procedure] in West Bengal & Sikkim Region.

But, one thing is not clear from your letter whether the Board is considering to hold the re-examination for all including those, who have already cleared the examination or will exempt the successful candidates from re-appearing. For example, around 47% of the total examinees of West Bengal Region, who appeared in paper II in 2016 Examination, have cleared it successfully. In the meantime, a representation has been received from JCA, W.B expressing dissent on holding examination again in Paper II (Office procedure) for all irrespective of successful & un-successful candidates appeared in the last examination.

Under the given circumstances, it is, therefore, requested to kindly appraise whether the option given by you to hold re-examination in Paper – II (Office Procedure) may be exercised only for those candidates who could not clear the Paper II (Office Procedure) of the last examination held on 26.07.2016.
