# In view of diversion of CIT (LTU), Kolkata charge, Sri Kumar is hereby deemed to have been posted in the O/O the Pr.CCIT WB & Sikkim w.e.f 25.09.2020 until the date of joining in the new place of posting as mentioned in this order.

**PART C :**

(i) In the case of employees who are on sanctioned leave / in training as on 18.12.2020, this order will take effect on their return from such leave / training.

ii) The joining time shall be admissible as per DOP&Ts notification dtd.27.03.2015 in this regard.

iii) With this order, all representations / options for transfer & postings in the grade of Stenographers received in this office till date, stand disposed off. No further request regarding transfer and posting will be entertained unless the official concerned join to his / her new place of posting.

iv) All the officials in the cadre of Stenographer, who have been transferred by this order should be relieved on or before **24.12.2020** positively under intimation to this office, except those, who are involved in Vivad Se Viswas (VsV) Scheme related works for which necessary order have been made by the concern PCIT/CIT for this purpose. Officials who are not involved in VsV related works shall be treated as "**stand released**" w.e.f **24.12.2020 (A.N)** from their present/erstwhile places of posting

v) Transfer & posting of all the officials in the cadre of Stenographer of Income Tax, West Bengal & Sikkim Region, effected by this office **order No. 14 dated 23.09.2020** issued from even file but not covered in this order shall also be treated as "**stand released**" w.e.f **24.12.2020 (A.N.)** from their present/erstwhile places of posting unless they have already joined their new assignment as per such order by this time. However, this clause will not be applicable to those Stenographers who are involved in Vivad Se Viswas (VsV) Scheme related works for which necessary order have been made by the concerned PCIT/CIT for this purpose.

vi) The concerned A.O./D.D.Os in charge of drawing & disbursing pay & allowances of the transferred officials as per this order & this office **order no. 14 dated 23.09.2020** as mentioned above, are hereby directed **not to draw** any pay & allowances in respect of such officials from the month of January, 2021 onwards.

vii) All the Head of offices should send compliance reports, where applicable, for relieving and joining of the officials to this office latest by **29.12.2020**.
