- All the officials in the cadre of Notice Server, West Bengal & Sikkim Region who have been transferred by this order should be **relieved** on or before **31.12.2020** positively under intimation to this office, except those, who are involved in Vivad Se Viswas(VsV) Scheme related works for which necessary order have been made by the concern PCIT/CIT for this purpose. Officials who are not involved in VsV related works shall be treated as **"Stand Released" w.e.f. 31.12.2020 (A.N.)** from their present/erstwhile places of posting.
- Transfer & posting of all the officials in the cadre of Notice Server, West Bengal & Sikkim Region, effected by the office **order No. 19 dated 01.10.2020** and **Order No. 31 dated 06.11.2020**



issued from the even file but not covered in this order shall also be treated as "Stand Released" w.e.f. 31.12.2020 (A.N.) from their present/erstwhile places of posting unless they have already joined their new assignment as per such order by this time. However, this clause will not be applicable to those Notice Server who are involved in Vivad Se Viswas(VsV) Scheme related works, for which necessary orders have been made by the concerned PCIT/CIT for this purpose.

(vi) The concerned A.O./D.D.Os in charge of drawing & disbursing pay & allowances of the transferred officials as per **this order**, the office **order No. 19 dated 01.10.2020** and **Order No. 31 dated 06.11.2020**, as mentioned above, are hereby directed **not to draw any pay & allowances** in respect of such officials from the month of **January, 2021** onwards.
