- iii) All the above mentioned officials appearing are selected for ad-hoc promotion against unreserved vacancies.
- iv) Ad-hoc Promotion of the above said persons are given on the basis of the existing Recruitment Rules, as directed vide Board's letter dated 23.02.17, and as per revised final gradation list of the feeder grades in implementation of the Hon'ble Apex Court Judgment in the N.R. Parmar case.
- v) The promotees concerned are directed to join on promotion as Office Superintendent at the earliest. They are also directed to intimate their unwillingness, if any, to accept the promotion to the post of Office Superintendent to this office by one month from the date of this order positively, otherwise action will be taken as per extent rules.

vi) . The above mentioned officials are not entitled to exercise the option in the matter of fixation of pay. Such option can be given only on their regular promotion as Office Superintendent against regular vacancies.
