Part-A: पदोन्नति / Promotion:

Part-B:

- The promotion is valid for one year in terms of Para No.7 of DoP&T's O.M. No. 28036/1/2001-Estt.(D) dated 23.07.2001.
- All the conditions prescribed in the existing DoP&T's instructions regarding ad-hoc promotion shall be applicable to this promotion.
- The above ad-hoc promotion is made as per the seniority of the eligible candidates in the feeder grade, without any element of reservation for the SC/ST category.
- This promotion is subject to any subsequent O.M./clarification/instruction of the DoP&T /CBDT regarding the procedure of implementation of the judgment of the Hon'ble Supreme Court of India dated 26.09.2018, in SLP(C) No. 30621/2011, or any other such judgment of the Hon'ble Supreme Court of India. In this regard, the above official is liable to be reverted at any time without assigning any reason, as a consequence of it.
- The ad-hoc promotion of the above said official shall not confer on the official concerned any right to claim seniority in the grade of Staff Car Driver, Grade-II, or regular promotion as Staff Car Driver, Grade-II.
- The promotee concerned is directed to join on promotion as Staff Car Driver, Grade-II at the earliest. He is also directed to intimate his unwillingness, if any, to accept the promotion to

the post of Staff Car Driver, Grade-II to this office by **one month from the date of this order** positively, **otherwise action will be taken as per extant rules.**

vii) - The above person may please note that in the event of refusing promotion, he will be debarred from promotion to the post of Staff Car Driver, Grade-II for a period of one year from the date of refusal of said promotion or till a next vacancy arises whichever is later as per the D.O.P & T's OM No. 22011/5/91-Estt(D) dated 27.03.1997.

viii) The official appearing in Part-A of this order is allowed to join at his present place of posting. The above posting on promotion is purely temporary and the promotee concerned is liable to be transferred to any office within the West Bengal & Sikkim region at any time.

ix) The above mentioned official is not entitled to exercise the option in the matter of fixation of pay under F.R.22(1)(a)(1). Such option can be given only on his regular promotion as Staff Car Driver, Grade-II against regular vacancy.

x) Head of office is requested to ensure that the copy of the joining report is sent to the office of the Addl. CIT, Hqrs., (Personnel & Establishment), Kolkata as soon as the said person join on promotion.


