4. Implementation of any instruction / guideline which may be issued by the DoP&T /CBDT, New Delhi, having bearings in the matter of the above regular promotions.
5. Any other order / judicial pronouncement on these issues.
6. The date of joining of the above officials in the higher grade on promotion, will be subject to review / modification on grounds of any clarification / direction received from the CBDT.
7. The above officials are hereby asked to exercise their option within 1(one) month from the date of promotion in the matter of fixation of pay on such promotion in terms of para 3 of the Ministry of Personnel, Public Grievance & Pension (DoPT) O.M. 
