Part -I Promotion :

- i) The above mentioned officials, being promoted as per this order, are liable to be reverted without prior notice at any time.
- ii) The above promotees are hereby asked to exercise their option within one month of the date of promotion in the matter of fixation of pay on such promotion in terms of Clarification 2 of O.M. F. No. 1/1/2008-1C G.I.M.F, Deptt. of Expenditure (Implementation Cell) dated 13th September, 2008.
- iii) It may be noted that in the event of refusing the above promotion the officials getting promotion as per this order shall be debarred from promotion to the post of Office Superintendent for a period of one year from the date of refusal of the said promotion or till a next vacancy arises, whichever is later, as per the D.O.P & T's O.M. No. 22011/5/91-Estt.(D) dated 27.03.97.
- iv) The above mentioned persons appearing are selected against unreserved vacancies.
- v) Promotions of the above said persons had to be given on the basis of the existing Recruitment Rules, as directed vide Board's letter dated 27.05.2014, and as per the existing gradation list of the feeder grade, and the same would be subject to revision contingent upon the revision of the said gradation list of the feeder cadre in view of the decision of the Hon'ble Supreme Court in the case of N.R.Parmar & Others, read with DoP & T's O.M. dt. 04.03.2014 & CDBT's letter dated 06.06.2014, 29.09.2014, & 07.11.2014, communicating further clarifications of the Dop & T's O.M. dated 04.03.2014, in the lower grades .

vi) **The promotees concerned are directed to join on promotion as Office Superintendent at the earliest to the places of posting as mentioned in Column No.5 of the table above.** They are also directed to intimate their unwillingness, if any, to accept the promotion to the post of Office Superintendent within one month from the date of this order positively, failing which action taken will be taken as per extent rules

vii) The above postings on promotion is purely temporary and the promotees concerned are liable to be transferred to any office within the Principal CCIT(CCA), West Bengal & Sikkim region at any time.
