Sub:- Ministerial Staff Examination Paper-II (Office Procedure)- reg.

I am directed to convey that a lot of complaints were received that sufficient number of prescribed books were not available during the course of Paper-II of Ministerial Departmental Examination -2016. The statistics made available show that in most of the centres, number of sets of prescribed books available in the examination hall were less than the number of examinees. This shows that some candidates might have faced shortage of prescribed books while writing this examination and therefore their result could have suffered. Taking into account all these facts, it is decided that another attempt needs to be given to the unsuccessful candidates who had appeared in exam for Paper-II of the Ministerial Staff Examination-2016.

2. Accordingly, it is directed that re-examination for paper-II of the Ministerial Staff Examination-2016 be held on 19.03.2017. All the unsuccessful candidates who had earlier appeared in this paper in 2016 would be eligible to give this re-examination. The result of candidates who have already qualified this paper in 2016 will stand and they need not appear in this paper again.

3. The question papers can be collected from this office on 16th & 17th March, 2017 (Thursday & Friday). The officer deputed in this regard should come with duly authorized requisition from the concerned Pr. CIT (In-charge of Examination).

4. Sufficient books should be provided to the candidates appearing for the examination both in English and Hindi, as applicable. The number of sets of books should be equal to the number of candidates appearing in the examination.

5. Number of candidates appearing in Hindi may be sent to this office by return of fax.

6. In so far a Mumbai charge is concerned, the re-examination in Mumbai charge will also now be held on 19.03.2017 along with the other regions.

7. Kindly inform per return FAX, number of candidates who shall be eligible to take exam on 19.03.2017.
