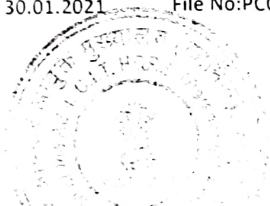

Part-II:

The order in which the names of the aforesaid officials appear in the above table does not indicate their inter - se seniority in the grade of Inspector of Income Tax. Their regularization as Inspector of Income Tax, is based on their names being common in the consideration zone both on the basis of the pre - N. R. Parmar and post - N. R. Parmar seniority lists of the feeder grades (Office Superintendent, Senior Tax Assistant, Tax Assistant, Stenographer, Grade - I / II). The final allocation of regularization against vacancy years for the above regularized Inspectors of Income Tax would be determined on the basis of the final seniority list whenever determined as per the outcome of the conditions elaborated below. The inter -se seniority in the grade of Inspector of Income Tax, vacancy years against which the above mentioned Inspectors of Income Tax are regularized, and the effective date (s) of regularization, if any, will be subject to the outcome of the conditions elaborated below:

The regularization of the above mentioned officials in the grade of Inspector of Income Tax is subject to:

1. Final outcome of SLP (C) 30621 of 2011, in the case of Jarnail Singh and Ors. vs. Lachhmi Narain Gupta and Ors., still pending before the Hon'ble Supreme Court of India.
2. Any instruction / clarification of the DoP & T regarding interpretation / implementation of the judgement of the Hon'ble Supreme Court of India in C. A. No. 8833 - 8835 of 2019, in the case of K. Meghachandra Singh & Ors. vs. Ningham Siro & Ors..
3. Clarification on order dated 21.11.2019, in O. A. No. 350 / 01530 of 2019, in the case of Satyabrata Pramanick vs. U. O. I. & Ors., sought from the Hon'ble Central Administrative Tribunal, Kolkata.
4. Implementation of any instruction / guideline which may be issued by the CBDT / HRD, New Delhi, in compliance of the judgement delivered by the Hon'ble Supreme Court of India, in the case of Pratibha Rani & Ors. vs. Union of India & Ors..
5. Any other order / judicial pronouncement on these issues.
