**पार्ट- II / PART - II :**

i) The promotion is valid for one year in terms of Para No.07 of DoP&T's O.M. No. 28036/1/2001-Estt.(D) dated 23.07.2001. The above promotion on **ad- hoc basis** shall not confer on the officials concerned any right to claim seniority in the grade of Sr. Tax Assistant or regular promotion as Sr. Tax Assistant.

ii) All the conditions prescribed in the existing DoP&T's instructions shall be applicable to this promotion.

iii) The above ad-hoc promotions are made as per the seniority of the eligible candidates in the feeder grade, without any element of reservation for the SC/ST category.

iv) This promotion is subject to any subsequent O.M./clarification/instruction of the DoP&T/CBDT regarding the procedure of implementation of such judgment of the Hon'ble Supreme Court of India dated 26.09.2018, in SLP(C) No. 30621/2011, or any such judgment of



the Hon'ble Supreme Court of India. In this regard, the above officials are liable to be reverted at any time without assigning any reason, as a consequence of it.

v) The ad-hoc promotions of the above said officials are based on the revised seniority list published after giving effect to the judgment of the Hon'ble Apex Court's in the N.R. Parmar & Ors. Vs Union of India & Ors., and is subject to change in seniority of any official subsequent to any representation received later on by this office and/or any decision of any proceeding pending before any tribunal/court/CBDT/DoPT.

vi) The promotees concerned are directed to join on promotion as Sr. Tax Assistant at the earliest. . They are also directed to intimate in case of declining promotion to the post of **Sr. Tax Assistant**, if any, to this by **one month from the date of this order** positively.

vii) The above mentioned officials are not entitled to exercise the option in the matter of fixation of pay. Such option can be given only on their regular promotion as Office Superintendent against regular vacancies.

viii) **The officials appearing in Part-I of this order are allowed to join at their present place of posting.** The above posting on promotion are purely temporary and the promotees concerned are liable to be transferred to any office within the West Bengal & Sikkim region at any time.

ix) The above persons are liable to be reverted at any time without assigning any reason.

x) The above mentioned persons are not entitled to exercise the option in the matter of fixation of pay under F.R.22(1)(a)(1). Such option can be given only on their regular promotion as Sr. Tax Assistant against regular vacancies.

xi) The above persons may please note that in the event of their refusing promotion, they will be debarred from promotion to the post of Sr. Tax Assistant for a period of one year from the date of refusal of said promotion or till a next vacancy arises whichever is later as per the D.O.P. & T's OM No. 22011/5/91-Estt(D)dated 27.03.97.

xii) Heads of office are requested to ensure that the copy of the joining report is sent to the office of the Addl.CIT., Hqrs., (Personnel & Establishment), Kolkata as soon as the said person joins on promotion.
