Part-A: Promotion :

- v) It may be noted that in the event of refusing the above promotion the officials getting promotion as per this order shall be debarred from promotion to the post of Stenographer Gr. I for a period of one year from the date of refusal of the said promotion or till a next vacancy arises, whichever is later, as per the D.O.P & T's O.M. No. 22011/5/91-Estt.(D) dated 27.03.97.
