Deployment of Tax Assistants

2. This Order is passed in **supersession of all earlier Orders** passed in respect of the officials named in the Order.


3. All the officials mentioned in the Order should be relieved on or before **29.05.2015** positively under intimation to this office. No representation whatsoever will be entertained before the officials join at their new places of posting. All the Heads of offices should sent compliance reports regarding relieving and joining of the officials to this office by **05.06.2015**.

4. The persons who are posted in **Mofussil offices** should join their new place of posting on or before **12.06.2015** without any fail. Otherwise the services rendered by them in Mofussil offices during 2013-14 will not be counted for the purpose of determining the tenure of their stay in Mofussil offices at the time of their return from such Mofussil offices in the subsequent this office's Annual General Transfer Order.
