**Deployment of Tax Assistants :**

2. All the officials mentioned in the Order should be relieved on or before **05.05.2017 positively** under intimation to this office. **No representation whatsoever will be entertained before the officials join at their new places of posting.** All the Heads of offices should sent compliance reports regarding relieving and joining of the officials to this office by **12.05.2017.**
3. The persons who are posted in **Mofussil offices** should join their new place of posting on or before **19.05.2017** without any fail. Otherwise the services rendered by them in Mofussil offices during 2017-18 will not be counted for the purpose of determining the tenure of their stay in Mofussil offices at the time of their return from such Mofussil offices in the subsequent this office's Annual General Transfer Order.
4. All Administrative Pr.CsIT/CsIT are requested to rotate the officials posted under his/her charge, whenever the officials completed 2 years under one particular CIT/ Range Office.
