### NOTIFICATION NO. 1

(Income-tax)

Kolkata, dated the 15th November, 2014.

- 1. In pursuance of the notification of the Central Board of Direct Taxes in S.O. 2752 (E) [Notification No. 50/2014/F.No. 187/38/2014(ITA.I)] dated 22<sup>nd</sup> October, 2014 and Director General of Income-tax (Human Resources Development), Central Board of Direct Taxes, New Delhi Communication from F. No. HRD/CM/102/28/2013-14/27 dated 4<sup>th</sup> March, 2014 and subsequent Corrigendum from F. No. HRD/CM/102/28/2013-14/4488 dated 17<sup>th</sup> October,2014 and in suppression of all earlier orders on the subject, except as respects things done or omitted to be done before such suppression, the principal Chief Commissioner of Income-tax, West Bengal and Sikkim hereby directs:-
  - (a) abolition of existing charges of Ranges, Circles, Wards and Tax Recovery Units, functioning under the administrative control of the Chief Commissioner of Income-tax, Kolkata-I to V and Kolkata-VIII to XI, Chief Commissioner of Income-tax, Durgapur and Chief Commissioner of Income-tax, Jalpaiguri;
  - (b) creation of Special Ranges/ Ranges headed by Additional Commissioners of Income-tax / Joint Commissioners of Income-tax specified in column (4) of the Schedule annexed hereto having their headquarter specified in the corresponding entry in column (3) of the said Schedule which shall function under the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule.
  - (c) creation of circles headed by Deputy Commissioners of Income-tax / Assistant Commissioners of Income-tax specified in column (4) of the Schedule annexed hereto having their headquarter specified in the corresponding entry in column (3) of the said Schedule which shall function under the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule.

- (d) creation of Wards headed by Income-tax Officers specified in column (4) of the Schedule annexed hereto having their headquarter specified in the corresponding entry in column (3) of the said Schedule which shall function under the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule, and
- (e) creation of Tax Recovery Units headed by Tax Recovery Officers specified in column (4) of the Schedule annexed hereto having their headquarter specified in the corresponding entry in column (3) of the said Schedule which shall function under the Income-tax Authorities specified in the corresponding entry in column (2) of the said Schedule.
- 2. This order shall come into force with effect from 15th of November, 2014.
