Sub: CS(MA) Rules 1944 Renewal of name of the AMA for the treatment of Central Govt. Employees' and Members of their family for the period from 01.08.2019 to 31.07.2020.-Extension thereof - matter regarding

Ref: Circular 1 & 2/2019-20 in F.No. CGEWCC/Kol/16/2019-20/AMA-1/697 dated 02-08-2019 & F.N o. CGEWCC/Kol/16/2019-20/AMA-2/705 dated 02-08-2019 respectively

In terms of Ministry of Health & Family Planning's (Department of Health) instructions contained in O.M. No. 9-14025/133/79-MS dated 28.05.1982 and C & A.G. Circular No. 445-Audit/17/87/III-90 (86) dated 10.08.1990 and as per Rule 2A (iv) of the CS(MA) Rules 1944, the name of the Private Medical Practitioners were empanelled as AMA for the year 2019-20 and the panels of AMA were valid till 31-07-2020 as mentioned in the above referred Circular but due to Covid-19 outbreak throughout the country the Private Medical Practitioners included in the above referred panel are not being able to submit their applications for renewal of AMA for the next term.

In view of the above the existing panels of AMA as mentioned in Circular 1 & 2 the validity of which were going to expire on 31-07-2020 were previously extended upto 31-12-2020. But due to the same Covid-19 situation a large number of the AMAs could not submit their renewal application. Therefore the validity of the above referred panels of AMA are further extended upto 31-03-2021 with the same terms and condition.
