- The above mentioned officials, being promoted as per this order, are liable to be reverted without prior notice at any time.
- ii) The above promotion on **ad- hoc basis** shall not confer on the officials concerned any right to claim seniority in the grade of Inspector of Income Tax or regular promotion as Inspector of Income Tax.
- The officials appearing at Sl.Nos 3 to 21 are selected for ad-hoc promotion against UR vacancies & SL. No. 24 against PH vacancy. The persons appearing at Sl. No. 1 & 2 are selected against SC vacancies & Sl. No. 22,23,25 against ST vacancies.
- iv) Ad-hoc promotion of the above said officials are given on the basis of the existing Recruitment Rules, as directed vide Board's letter dated 23.02.2017, and as per revised final gradation list of the feeder grades in implementation of the Hon'ble Apex Court Judgment in the N.R. Parmar case.



- v. The promotees concerned are directed to join on promotion as Inspector of Income Tax at the earliest. The officials are also directed to intimate their unwillingness, if any, to accept the promotion to the post of Inspector of Income Tax to this office by one month from the date of this order positively, otherwise action will be taken as per extent rules.
- vi) If any of the officials has been given the benefit of pay fixation under ACP Scheme 1999/MACP Scheme 2008, he/she shall not be eligible for any pay fixation now. Fixation of pay may be revised and the officials may be allowed to give options thereon as per rule FR 22(1)(a)(1) subject to any Government Orders/Instructions/Court Orders and also in the event of regular promotion against regular vacancies.

- i) On promotion as Inspector of Income Tax, the services of the officials mentioned in Part A are retained at their present places of posting until further orders.
- ii) The above posting on promotion is purely temporary and the promotees concerned are liable to be transferred to any office within the Principal CCIT West Bengal and Sikkim region.
