Sub: Interactive session and meeting of members of Central Headquarters / Regional Executive Committees of ITGOA & ITEF with the Chairman, CBDT at New Delhi on 14-10-2017— matter reg.

All of you are aware that a number of issues concerning the members of JCA are pending at different levels of hierarchy at CBDT for long as proper initiatives to resolve the issues have not been taken by the concerned authority inspite of official decisions in regard to such issues at various meetings including PGRC and QRM. Also, bringing changes in the set up norms and practices of the Departmental works, by way of various OMs, Circulars, Instructions, Executive orders etc. and by introducing various new Schemes, has become the order of the day creating unmanageable hardship for the officers/officials working at field.

- 2. Keeping all this in mind, the Central JCA has requested the Chairman, CBDT to attend a meeting convened by the Central JCA and address the house in regard to:
 - i) the intension of the Board in resolving the long pending Personnel/Human Resources related issues, disturbing the minds of our members, and
 - ii) the road map of duties and responsibilities ahead of us.
- 3. We had also requested him to hold an interactive session. It is our pleasure to inform that the Hon'ble Chairman, CBDT had consented for the same. The meeting will be held at the Conference Room, Civic Centre Building, New Delhi on 14-10-2017 (Saturday) at 4.00 PM, followed by High-Tea. This is an opportunity for us to raise all issues relating to recruitment/ promotion / transfer/ infrastructure/ Departmental intranet connectivity / training / manpower-shortage/ outsourcing etc. and also the problems faced by the officers/officials working in field offices in implementing the new amendments in Departmental procedures like the switch over as per

instruction dated 29.09.2017, etc. /pressure of excessive reports/inadequate system-support/high-handedness of regional authorities, etc.

- 4. It has been decided that the meeting will be attended by **all members of the Central Headquarters of both ITGOA & ITEF and also the Presidents and General Secretaries of all 18 Units of ITGOA/Circles of ITEF.** For the regions where the Presidents/General Secretaries hold the posts in the CHQ or the Presidents/General Secretaries will not be available for some other reason, replacements should be sent.
- 5. We feel that all members of the Central Headquarters of both ITGOA & ITEF and also the Presidents and General Secretaries of all 18 Units of ITGOA/Circles of ITEF should attend the said meeting without fail. Units/Circles of ITGOA/ITEF and the members of CHQ are requested to confirm their attendance in the meeting and also send the issues which they consider relevant / important to be taken up by the Central JCA with the Chairman in this meeting on or before 07-10-2017.
