ORDER UNDER SUB-SECTION (1), (2) and (3) OF SECTION 120 OF THE INCOME-TAX ACT, 1961

In exercise of the powers under sub-sections (1), (2) and (3) of Section 120 of the Income-tax Act, 1961 conferred upon me by the Government of India, Central Board of Direct Taxes, New Delhi, vide Notification No. 66/2014 in F. No. 279/Misc./66/2014- SO (ITJ) dated 13<sup>th</sup> November, 2014 published in the Gazette of India Extraordinary in Part II, Section 3, Sub-section (ii) number S.O.2907(E) dated the 13<sup>th</sup> November, 2014 and in exercise of all other powers enabling me on this behalf, I, the Principal Chief Commissioner of Income-tax, West Bengal and Sikkim, hereby direct –

- (i) that the appeals filed by cases or classes of cases of persons specified in column (4) of the Schedule annexed hereto are deemed to have been transferred with effect from 15<sup>th</sup> November, 2014 from erstwhile [pre-restructuring] Commissioner of Income-tax (Appeals) specified in the corresponding entries in column (2) of the said Schedule to the new [post-restructuring] Commissioner of Income-tax (Appeals) specified in the corresponding entries in column (3) of the said Schedule, and;
  - (ii) that the Commissioner of Income-tax (Appeals) specified in column (3) of the said Schedule shall transfer the appeals filed by cases or classes of cases of persons specified in column (4) of the said Schedule which do not pertain to his/ her jurisdiction as notified vide Order No. 4 dated 15<sup>th</sup> November, 2014 immediately to such Commissioner(s) of Income-tax (Appeals) who would otherwise hold jurisdiction over those cases as per the new jurisdiction Order No. 4 dated 15<sup>th</sup> November, 2014.
2. This order shall come into force with immediate effect.
