- i) The promotion is valid for one year in terms of Para No. 07 of DoF&T's O.M. No. 28036/1/2001-Estt.(D) dated 23.07.2001.
- ii). All the conditions prescribed in the existing DoP&T's instructions shall be applicable to this promotion.
 - iii) The above ad-hoc promotions are made as per the seniority of the eligible candidates in the feeder grade, without any element of reservation for the SC / ST category.
 - iv) This promotion is subject to any subsequent O.M./clarification/instruction of the DoP&T/CBDT regarding the procedure of implementation of such judgment of the Hon'ble Supreme Court of India dated 26.09.2018, in SLP(C) No. 30621/2011, or any such judgment of the Hon'ble Supreme Court of India. In this regard, the above officials are liable to be reverted at any time without assigning any reason, as a consequence of it.
 - v) The promotions of the above said officials on ad-hoc basis shall not confer on the official concerned any right to claim seniority in the grade of Notice Server, on regular promotion as Notice Server.
 - vi) The ad-hoc promotions of the above said officials are based on the revised seniority list published afterwaving retrospective effect to the judgment of the Hon'ble Apex Courtes the N.R. Parmar & Ors. Vs Union of India & Ors. from 1986 onwards, and is subject to any further revision of seniority list in view of the CBDT's revised instruction regarding implementation of the N.R. Parmar judgement of the Hon'ble Apex Court vide its letter dated 27.05.2019.
 - vii) The promotees concerned are directed to join on promotion as Notice Server at the earliest. They are also directed to intimate their unwillingness, if any, to accept the promotion to the post of Notice Server to this office by **one month from the date of this order** positively, **otherwise action will be taken as per extant rules**.
 - viii) The above mentioned officials are not entitled to exercise the option in the matter of fixation of pay. Such option can be given only on their regular promotion as Notice Server against regular vacancies.

- i) On promotion as Notice Server, the services of the officials mentioned in Part A are retained at their present places of postings until further orders.
- ii) The above posting on promotion is purely temporary and the promotees concerned are liable to be transferred to any office within the Principal CCIT West Bengal and Sikkim region.
