

Part-A: Promotion:

In pursuance of C.B.D.T.'s instruction vide its letter F.No. HRD/CM/102/10/2014-15 Dated: 17.06.2015, the following officials are promoted to the grade of **Office Superintendent** in the respective **Pay Band** plus **Grade Pay** (as applicable) along with usual allowances against the existing vacant posts arisen due to recent promotion in higher grades as per the recommendation of the DPC with effect from the date they join for duty and until further orders.

- i) The person appearing at SI. No. 05 who is on foreign service in Income Tax Employees Federation, may either claim proforma promotion from the borrowing organization or may be reverted back and join in the cadre to avail his promotion.
- ii) The promotion of the person appearing at SI. No. 06 is on ad-hoc basis till the vacancy due to foreign service of the person at SI. No. 05 exists or a subsequent regular vacancy arises, whichever is earlier.
- iii) The above mentioned officials, being promoted as per this order, are liable to be reverted without prior notice at any time.



- iv) The inter-se seniority of the above mentioned persons in the promotional grade of Office Superintendent will be fixed in accordance with the revised panels for promotion as OS drawn up by review DPCs in implementation of the Hon'ble Apex Court's judgment in the N.R. Parmar case.
- v) The above **promotees** are hereby asked to exercise their option within one month of the date of promotion in the matter of fixation of pay on such promotion in terms of Clarification 2 of O.M. F. No. 1/1/2008-1C G.I.M.F, Deptt. of Expenditure (Implementation Cell) dated 13th September, 2008.
- vi) If may be noted that in the event of refusing the above promotion the officials getting promotion as per this order shall be debarred from promotion to the post of Office Superintendent for a period of one year from the date of refusal of the said promotion or till a next vacancy arises, whichever is later, as per the D.O.P & T's O.M. No. 22011/5/91-Estt.(D) dated 27.03.97.
- vii) All the persons mentioned above are selected for promotion against UR vacancies.
- viii) Promotions of the above said persons are given on the basis of the existing Recruitment Rules, as directed vide Board's letter dated 17.06.15, and as per the existing gradation lists of the feeder grades. This order will remain subject to revision contingent upon the revision of the said gradation lists of feeder cadres that may occurred in the process of implementation of the Hon'ble Apex Court Judgment in the N.R. Parmar case, and read with DoP & T's O.M. dt. 04.03.2014, & CBDT's letters dated 06.06.2014, 29.09.2014, & 07.11.2014, communicating further clarifications of the DoP & T's O.M. dt. 04.03.2014, in the lower grades.
- ix) The promotees concerned are directed to join on promotion as Office Superintendent at the earliest. They are also directed to intimate their unwillingness, if any, to accept the promotion to the post of Office Superintendent to this office by one month from the date of this order positively, otherwise action will be taken as per extent rules.

Part-B: Posting

- i) On promotion as Office Superintendent of Income Tax, the services of the officials mentioned in Part –
 A are retained at their present places of postings until further orders.
- ii) The above posting on promotion is purely temporary and the promotees concerned are liable to be transferred to any office within the Principal CCIT West Bengal and Sikkim region.
- iv) Head of offices are requested to ensure that the copy of the joining report is sent to the office of the Addl.C.I.T./JCIT,Hqrs.,(Personnel), Kolkata as soon as the said persons join on promotion.
