#### Part A: Promotion:

In pursuance of CBDT's instruction vide letter F.No. HRD/CM/102/2/2014-15/7062 dated 02.12.2014, the following Senior Tax Assistants are hereby promoted to the grade of Office Superintendents in the respective Pay Band plus Grade Pay (as applicable) along with usual allowances against existing vacant posts for the R.Y. 2015-16 with effect from the date they join for duty and until further orders.

i) The above mentioned officials, being promoted as per this order, are liable to be reverted without prior notice at any time.

ii) The above promotees are hereby asked to exercise their option within one month of the date of promotion in the matter of fixation of pay on such promotion in terms of Clarification 2 of O.M. F. No. 1/1/2008-1C G.I.M.F, Deptt. of Expenditure (Implementation Cell) dated 13<sup>th</sup> September, 2008.

iii) The inter-se seniority of the promotees on promotion as Office Superintendents will be fixed immediately below SHRI JADU GOPAL ACHARYA (D.O.B.- 28.12.56), the last person promoted as Office Superintendent against the R.Y.-2015-16 vide Order No. 79 dated 05.08.2015 of F. No.- 5E/11/2015-16.

iv) It may be noted that in the event of refusing the above promotion the officials getting promotion as per this order shall be debarred from promotion to the post of Office Superintendent for a period of one year from the date of refusal of the said promotion or till a next vacancy arises, whichever is later, as per the D.O.P & T's O.M. No. 22011/5/91-Estt.(D) dated 27.03.97.

v) The above mentioned persons are selected against UR vacancies.

vi) Promotions of the above said persons are given on the basis of the existing Recruitment Rules, as directed vide Board's letter dated 02.12.2014, and as per the existing gradation list of the feeder grade. This order will remain subject to revision, contingent upon the revision of the said gradation list of feeder cadres that might occur on implementation of the rules set by the Hon'ble Supreme Court in the case of N.R.Parmar & Others, read with DoP & T's O.M. dt. 04.03.2014, in the lower grades & CBDT's letter dated 06.06.2014, 29.09.2014 and 07.11.204 communicating further clarification of the DoPT' OM dated 04.03.2014 in this regard.

vii) The promotees concerned are directed to join on promotion as Office Superintendent at the earliest. They are also directed to intimate their unwillingness, if any, to accept the promotion to the post of Office Superintendent to this office by **18.09.2015** positively.

#### Part-B: Posting

- i) On promotion as Office Superintendent, the services of the officials mentioned in Part-A are retained at their present places of postings as mentioned in Column No.5 of the table above until further orders.
- ii) The above posting on promotion is purely temporary and the promotees concerned are liable to be transferred to any office within the **Principal CCIT West Bengal and Sikkim** region.
- Head of offices are requested to ensure that the copy of the joining reports are sent to the office of the AddI.C.I.T., Hqrs., (Personnel & Establishment), Kolkata as soon as the said persons join on promotion.
