Sub: Promotion to the post of Tax Assistant from the post of M.T.S-

regarding.

Ref: Our letter dated 13/12/2018 and 21/12/2018.

Kindly refer to the above.

In this context, your kind attention is drawn to the promotion of Tax Assistant from the cadre of M.T.S. We have expressed our opinion in this regard after Hon'ble CAT's order dated 05/10/2018. Further, we have requested you to kindly let us know whether the judgment of above mentioned order was taken into account while conducting the said DPC. The reply from your end is yet to be received. It noted from the CAT's order dated 5.10.2018 that the department has admitted that the Board's instruction vide letter dated 13.04.2005 was not followed while conducting the DPC for the promotion to the post of TA. It is also to be noted that the department is not following its own commitment made before the Hon'ble CAT.

Meanwhile, The Principal Chief Commissioner of Income Tax, Delhi , vide his order dated 01/01/2019, has passed the order granting promotion to 108 MTS to the post of Tax Assistant(copy enclosed). Thus, it is found that the Principal Chief Commissioner of Income Tax, Delhi has considered the issue in accordance to the CBDT's instruction dated 3/4.10.2018.

Under the circumstances, we are once again requesting you to settle the matter within the month of January,2019 so as to restore uniformity in the matter with the other region of the department and consider the MTS of this region for Promotion to the post of Tax Assistant as their counterparts have already been considered for such promotion in other regions like Mumbai, Kerala and Delhi etc. Otherwise we have no other alternative but to explore the other avenues to protect the interest of our members.
