As per the provisions of the constitution of this Federation, the above amount is to be paid by each Non-Gazetted employees, including MTS towards the renewal of membership in the month of April, 2018. You are, therefore, requested to take immediate action in this regard to obtain declarations of memberching by 35th March 1997, and ensure deduction from monthly pay bills for the month of April 1997, (if not already being done).
