- i) The promotees concerned are liable to be reverted without prior notice at any time.
- ii) The inter-se seniority of the promotee on promotion as Tax Assistant will be fixed immediately below **Ashok Kr. Santra**, (**Gen.**) (**DOB**: 10.01.68), the last person promoted as Tax Assistant against Recruitment Year 2014-15 vide Order No.205, dated 19-12-2014 of F.No.5E/5/2001-02(Sub).
- **iii)** The inter-se seniority of the promotes on promotion as Tax Assistant vis-à-vis direct recruit Tax Assistant will be fixed in accordance with the consolidated guidelines communicated vide DoPT's O.M. No. 20011/112008-Estt.(D) dated 11-11-2010 as modified vide DoPT's O.M. No. 20011/1/2012-Estt.(D) dated 04-03-2014
- **iv)** Persons appearing at Sl. No(s) 6, 24, 30, 32 & 33 all belonging to reserved categories, are adjusted, for the time being, against available unreserved vacancies, subject to the provision of future adjustment, whenever vacancies will arise for such respective categories subsequently, since it was decided by the administration to keep the application of the O.M. dated 10-08-2010 in abeyance.
- v) All other persons mentioned above are selected for promotion against unreserved vacancies.
- **vi)** Promotions of the above said persons are given on the basis of the existing Recruitment Rules, as directed vide Board's letter dated 17.06.2015, and as per the existing gradation list of the feeder grades.
- **vii)** All the above persons are hereby asked to exercise their options within one month of the date of promotion in the matter of fixation of pay on such promotion in terms of Clarification 2 of O.M.F.No 1/1/2008-1C G.I.M.F, Deptt. of Expenditure (Implementation Cell) dated 13th September,2008.
- **viii)** All the above persons will please note that in the event of their refusing promotion they will be debarred from promotion to the post of Tax Assistant for a period of one year from the date of refusal of said promotion or till a next vacancy arises, whichever is later, as per the D.O.P. & T's OM No. 22011/5/91-Estt(D)dated 27.03.97.
